

Seminar I-A

Business Entity Governance and Compliance

The State of Delaware is known as the "Corporate Capital" of the World. This seminar will provide information regarding why entities form/incorporate in the State of Delaware. Seminar I-D

Wining Litigation Technology (ParaCon/Sanction)

This seminar is intended to provide practical and useful suggestions for paralegals assisting practicing litigators, and to provide valuable techniques and guidelines to be used in the courtroom. After a brief overview of traditional courtroom presentation techniques to address their strengths and weaknesses, there will be an analysis of tools designed to enhance traditional presentation methods. Trial presentation software, timeline software, 3-D animation, proper digital formats, coordination with courtroom staff and other logistical considerations to be addressed prior to trial to ensure the successful deployment of technology. Participants will learn how to recognize how people process data and how to tailor the display of evidence to achieve maximum information retention. The effect of technology, including costs, the perception of its use by jurors and the efficiency it provides when properly implemented will be discussed. Contingency plans will be explored with regard to preparing for the unexpected and reviewing important backup measures to keep technology running smoothly throughout trial. Participants will see PowerPoint sample slides illustrating thematic techniques that can be used to effectively communicate information and how trial presentation software can be used in the courtroom to bring documents and images to life.

The trainer will present objective factors to determining innocence, such as use of eyewitness testimony at trial; as well as subjective factors, such as evidence not matching descriptions or actions. Proving innocence, including how the Post Conviction Relief Act, post-conviction DNA testing comes into play and requirements for presenting new evidence in post-conviction proceedings will be covered. Confidentiality is a key part of volunteering at the entry level, which includes screening letters, evaluating questionnaires and appellate materials, and reviewing and completing files for review by a Project attorney/committee.

E-Filing in Philadelphia County – An Overview

The First Judicial District of Pennsylvania, Court of Common Pleas of Philadelphia, launched its Civil Electronic Filing System in August 2008. Effective January 5, 2009, the electronic filing of all civil matters in Philadelphia became mandatory. Anyone handling civil cases should be a registered user of the system. This course will provide in-depth instruction on the use of the electronic filing system, as well as any and all enhancements and processes added to the system since implementation. The electronic filing system was designed to allow for the filing of all civil cases and legal documents via the Internet from anywhere and at anytime using a personal computer. The system currently provides attorneys and litigants with unlimited online access to all papers and legal documents filed in their cases.

The America Invents Act (AIA) was passed last Thursday and was sent to the President for signature. AIA is the most significant patent reform legislation in decades. The first-inventor-to-file system would give inventorship priority to the first individual inventor to file a patent application for a particular invention. The system follows the procedures already in place in Europe but would contrast sharply with the United States' current system, which gives priority to the first inventor in some circumstances even if that inventor is not the first to file an application with the U.S. Patent and Trademark Office. From Points North via I - 95 South

Follow I- 95 South to Central Philadelphia and take Exit 22 to 676 West. Follow 676 West for approximately one mile to the Broad Street exit. This will automatically put you onto 15th Street, heading South. Go ten lights to Locust Street and turn left. Go one block to Broad Street, turn left and proceed immediately into the center lane. Make a left into the garage for self-parking, or into Chancellor Court for valet parking and unloading luggage and / or passengers.

From Points North via New Jersey Turnpike (New York And Northern New Jersey)

Follow the New Jersey Turnpike to Exit 4, Route 73 North. Route 73 North (1.4 miles) will take you to Route 38 West (5.8 miles), which will lead you to Route 30 West. Follow the Atlantic City Expressway to Route 42 North to the Walt Whitman Bridge. Cross the bridge and take the Broad Street exit. Follow Broad Street approximately 2 miles north to Locust Street. Just as you pass Locust Street proceed immediately into the center lane. From the center lane make a left into the garage entrance for self-parking or into Chancellor Court for valet parking and unloading luggage or passengers.

From Points West via the Pennsylvania Turnpike and Northeast Extension

Follow the PA Turnpike to Exit 326 (former Exit 24) / Valley Forge Interchange and follow to Route 76 East. From Northeast Extension, follow Route 476 South to Route 76 East. Take Route 76 East to Exit 345 (former Exit 38) / Route 676 East (This exit is from the left lane). Go approximately ½ mile to the Broad Street / Central Philadelphia exit. At the top of the Broad Street exit ramp make an immediate right onto 15th Street. Go nine lights to Locust Street, and turn left onto Locust Street. Go one block to Broad Street. Make a left onto Broad Street. Proceed immediately into the center lane to make a left into garage entrance for self-parking or into Chancellor Court for valet parking and unloading luggage and / or passengers.
